

## COMPETITION TERMS AND CONDITIONS

### TERMS AND CONDITIONS OF THE KG MALL TROLLEY DASH COMPETITION

KG Mall (“KG Mall” or “Shopping Centre”), managed by Capital Land Asset Management, is conducting this promotional competition, which is called the “**KG Mall Trolley Dash Competition**”

All participants, by entering the “KG Mall Trolley Dash Competition”, agree to be bound by these Terms and Conditions:

#### 1. How to Enter:

- 1.1 Spend R100 or more at any store at KG Mall between 05 April 2024 to 5 June 2024, to stand a chance to be one (1) of three (3) lucky winners per month, for the duration of the competition, to WIN a 60 Second Trolley Dash.
- 1.2 To enter, write your name and contact number on your till slip and pop it into an entry box located in KG Mall. Entry boxes are located next to the Clicks Court and Shoprite Court
- 1.3 There is no limit to the number of entries permitted.

#### 2. Who Qualifies to Enter:

- 2.1 To participate in this competition, you must be a South African citizen or a permanent resident of South Africa with a valid passport or ID.
- 2.2 All entrants must be 18 years or older as of 5 April 2024.
- 2.3 The winner will be required to present a valid South African ID document or proof of permanent residency to accept and redeem the prize.
- 2.4 The winner must be willing and able to participate in the trolley dash within two weeks of the winner announcement.
- 2.5 The winner must be available to participate in the trolley dash between 06h45 to 08h00 on the agreed upon trolley dash date.

#### 3. Winner Selection Process:

- 3.1 The winners will be selected at random by means of a lucky draw.
- 3.2 Winners will be announced on once a month for the duration of the competition and entry boxes will be emptied on each announcement date.
- 3.3 Three (3) winners will win a 60 second trolley dash at a preselected supermarket store at KG Mall Shopping Centre to the maximum value of R6 000 including VAT.
- 3.4 The winners will be contacted via the contact details provided on the till slip entry.
- 3.5 The winners have one week from the announcement to respond. If no response is received within 7 days the prize will be forfeited.

#### 4. Prize & Collection Process:

- 4.1 The prize will be worth a maximum value of R6 000 including VAT and will include a Trolley Dash at a preselected supermarket store at KG Mall.
- 4.2 The winner must present their South African ID or valid passport and proof of permanent residency upon collection.
- 4.3 The winner’s name & contact details will be recorded by KG Mall Management for the purpose of Marketing campaigns and promotions.

- 4.4 The winner will be required to sign acceptance of their prize.
- 4.5 The winner agrees to all photos of the winner being used for KG Mall marketing, advertising, and reporting purposes.
- 4.6 The winner will be permitted one (1) Trolley Pusher during the Trolley Dash. A Trolley Pusher is someone that will assist the winner by pushing the trolley during the Trolley Dash.
- 4.7 The winner will be permitted to elect an individual to perform the Trolley Dash on their behalf if they are unable to do so due to physical disabilities or ailments.
- 4.8 The winner must be present at the Trolley Dash on the agreed date and time.
- 4.9 The final prize handover will take place at the till point.
- 4.10 The winner will be accountable for all costs exceeding R6 000 including VAT. Alternatively, the winner may elect to forgo items which may result in the prize value exceeding R6 000 including VAT.
- 4.11 The following items will not be included in the prize: alcohol; tobacco; and large appliances including but not limited to fridges, dishwashers, washing machines, televisions, stoves and ovens.
